## CITY COUNCIL CITY OF PIEDMONT APRIL 5, 2022 6:29 PM

The City Council of the City of Piedmont met in regular session at the time and on the date above. Present were Mayor Baker, Council Members John Lawrence, Richard Williams, Jubal Feazell, Caleb Pope, Greg South, David Ivey, and Terry Kiser.

Following the invocation by David Ivey and the pledge of allegiance given by Mayor Baker, the minutes were presented for consideration. Terry Kiser made the motion that the minutes be approved as presented. Richard Williams seconded the motion and the minutes passed with one abstention from Jubal Feazell.

The bills totaling \$464,028.51 were then presented for consideration for payment. Richard Williams made the motion that the bills be approved as presented. Terry Kiser seconded the motion and the bills were approved for payment.

The next item on the agenda was a school board appointment. Greg South made the motion to reappoint Bruce Adderhold to the School Board. Jubal Feazell seconded the motion and the motion carried unanimously.

The next order of business was the James Bennett land swap. Mr. Bennett is requesting the City swap his road frontage land for a city owned triangle piece of property that extends into his field. He will pay for survey and deed for the exchange. Jubal Feazell made the motion to enter into a land swap agreement with James Bennett. Richard Williams seconded the motion and the motion carried unanimously.

The AMEA representative was next on the agenda. Richard Williams made the motion that Greg South be the City representative for AMEA. Jubal Feazell seconded the motion and the motion carried unanimously.

There were no visitor comments.

In Council Reports John Lawrence had no report.

Richard Williams had no report.

Jubal Feazell made the motion to appoint Brian Young to the Commercial Development Board. Richard Williams seconded the motion and the motion carried unanimously. He also mentioned the side walk repair on Haslam Street.

Caleb Pope had no report.

Greg South wanted to report debris on the Trail on the Cleburne County side. This was due to a recent storm.

David Ivey wanted to thank Carl and Jeff for preparing information for the Lowe's Improvement Grant. He also wanted to give an update on the electronic work orders. They should be available to use in the near future.

Terry Kiser would like to see monies spent on the Civic Center to make it look nicer.

Clerk Hinton asked Council to consider purchasing two mowers for Street and two mowers for PARD. The total cost would be \$41,104.80 from Tri-Green. Richard Williams made the motion to purchase four mowers and use money from Capital Investment account. Terry Kiser seconded the motion and the motion carried unanimously. The next item was the bid opening for the complex lighting. The City received bids from Sequel and Mayer Electric. Greg South made the motion to accept the bid of \$97,400 from Sequel for ASD lighting. Caleb Pope seconded the motion and the motion carried unanimously.

In the Mayor's Comments he mentioned concerns of upcoming weather. He mentioned that Tina Dunbar would be doing a community cleanup. You can pick up trash bags at the Admin and a dumpster would be placed outside the Armory. The Piedmont Criterium Race will be Sunday from 8 -3. The opening day at PARD for baseball/softball was very successful. The Voting delegates for the City will be Bill Baker, Jubal Feazell, and Greg South. The Mayor wanted to let everyone know about the upcoming Easter Egg Hunt at the Assisted Living from 11-2.

With no other business to come before the Council, Greg South made the motion that the meeting be adjourned. John Lawrence seconded the motion and the meeting adjourned at 7:17 pm.
