The City Council of the City of Piedmont met in regular session at the time and on the date above. Present were Mayor Baker, Council Members John Lawrence, Jubal Feazell, Caleb Pope, Greg South, David Ivey, and Terry Kiser.

Following the invocation by John Lawrence and the pledge of allegiance given by Mayor Baker, the minutes were presented for consideration. Terry Kiser made the motion that the minutes be approved as presented. Jubal Feazell seconded the motion and the minutes were approved.

The bills totaling \$309,318.89 were then presented for consideration for payment. Jubal Feazell made the motion that the bills be approved as presented. David Ivey seconded the motion and the bills were approved for payment.

Ordinance # 638 was the next item on the agenda. Greg South made the motion to suspend the rules for immediate consideration of Ordinance # 638. Terry Kiser seconded the motion and a roll call vote was given. John Lawrence – yes, Jubal Feazell – yes, Caleb Pope – yes, Greg South – yes, David Ivey – yes, Terry Kiser – yes, and Mayor Baker – yes. The motion carried unanimously. Caleb Pope made the motion to approve Ordinance # 638. Jubal Feazell seconded the motion and the motion carried.
