The City Council of the City of Piedmont met in regular session at the time and on the date above. Present were Mayor Baker, Council Members Richard Williams, Jubal Feazell, Greg South, David Ivey, and Terry Kiser.

Following the invocation and the pledge of allegiance given by Mayor Baker, the minutes were presented for consideration. Terry Kiser made the motion that the minutes be approved as presented. Jubal Feazell seconded the motion and the minutes were approved.

The bills totaling \$145,210.75 were then presented for consideration for payment. Richard Williams made the motion that the bills be approved as presented. David Ivey seconded the motion and the bills were approved for payment.

Employee vacancy positions were the next item on the agenda. The Police Chief had two requests for the Council. The first was to fill a position that was being vacated by Matthew Kines. He is a dispatcher for the Police Department. Terry Kiser made the motion to post the position for dispatcher. Richard Williams seconded the motion and motion carried. The second request was to search for a fill in dispatcher from other local agencies to fill the dispatch position while the current dispatcher is on maternity leave. Greg South made the motion to use fill in personnel from other local agencies. Jubal Feazell seconded the motion and the motion carried.

The Alabama League of Municipalities Annual Convention and Voting delegate were next on the agenda. The Mayor let the Council know the dates of the convention and told them to see Patti before the end of the month if they planned on going. The Mayor also asked the Council if anyone had planned on going to the convention to let him know and they could be the voting delegate for the City.

Larry Davis spoke in visitor comments. He addressed the Council about an invoice that he received for requesting to re-locate a utility pole for his shop. He does not agree with the invoice.

In Council reports, John Lawrence was absent.

Richard Williams had no report.

Jubal Feazell had no report.

Caleb Pope was absent.

Greg South had no report.

David Ivey reported that the Council would receive a work order report monthly.

Terry Kiser reported that he placed a work order to patch holes in access road in front of Burger King.

Clerk Hinton told the Council that the 2021 knuckle boom had returned to service. He also told the Council that he received information from our opioid attorney and that we should be receiving another check shortly.

In the Mayor's comments he thanked Larry Davis for coming to the meeting. He told the Council that the sewer project on North Fifth Avenue was complete.
